Regardless of **Reason, Illness, or Injury**, players withdrawing from a tournament after 12 p.m. EST the **Saturday** before tournament week will be committed to the tournament purse but will be eligible for a refund of the course cost. Exception: If a professional player takes the open spot, the player will be given a full refund of their entry fee.
